Douglas, Potter Stewart, and Antonin Scalia have all pointed the way, and so has Justice Sandra Day O'Connor. People who don't want to hear it don't have to. People who want to hear it can do so, or even say Amen at the closing. It is not necessary to sneeze in unison for a commencement speaker to say God bless you.
