DEFINING CREATURES OF INFLUENCE IN THE INFORMATION SOCIETY

ENGAGEMENT AND INTERACTION

ACTIVE ENGAGEMENT WITH AUDIENCES THROUGH COMMENTS, LIVE SESSIONS, AND FEEDBACK LOOPS FOSTERS TRUST AND LOYALTY. THIS INTERACTIVITY ENHANCES THE CREDIBILITY AND EMOTIONAL CONNECTION BETWEEN CREATURES OF INFLUENCE AND THEIR FOLLOWERS.

NETWORK PROPAGATION AND VIRALITY

ETHICAL IMPLICATIONS AND CHALLENGES
