CREMATION PROCEDURE

THE CREMATION IS CONDUCTED IN A LICENSED FACILITY USING MODERN EQUIPMENT DESIGNED FOR EFFICIENCY AND RESPECT. THE BODY IS CREMATED AT HIGH TEMPERATURES UNTIL ONLY BONE FRAGMENTS REMAIN, WHICH ARE THEN PROCESSED INTO FINE ASHES.

RETURN OF CREMATED REMAINS

THE ASHES ARE PLACED IN A SIMPLE CONTAINER AND RETURNED TO THE FAMILY. FAMILIES MAY CHOOSE TO KEEP THE REMAINS, SCATTER THEM IN A MEANINGFUL LOCATION, OR ARRANGE FOR BURIAL OR ENTOMBMENT ACCORDING TO THEIR WISHES.

LEGAL AND PRACTICAL CONSIDERATIONS

CREMATION IS SUBJECT TO SPECIFIC LEGAL REQUIREMENTS IN MINNESOTA, WHICH THE CREMATION SOCIETY OF MINNESOTA ADHERES TO STRICTLY. FAMILIARITY WITH THESE RULES HELPS FAMILIES AVOID DELAYS AND ENSURES COMPLIANCE.

PERMITS AND DOCUMENTATION

THE SOCIETY MANAGES ALL NECESSARY PERMITS, INCLUDING THE CREMATION AUTHORIZATION FORM SIGNED BY THE LEGAL NEXT OF KIN OR AUTHORIZED REPRESENTATIVE. DEATH CERTIFICATES AND OTHER LEGAL DOCUMENTS ARE ALSO HANDLED EFFICIENTLY TO MEET STATE STANDARDS.

HOW SOON AFTER DEATH DOES CREMATION OCCUR?
