OVERVIEW OF THE CRIMINAL HISTORY SYSTEMS BOARD MASSACHUSETTS

THE CRIMINAL HISTORY SYSTEMS BOARD MASSACHUSETTS OPERATES AS A REGULATORY ENTITY RESPONSIBLE FOR OVERSEEING THE MANAGEMENT OF CRIMINAL RECORD INFORMATION THROUGHOUT THE STATE. ITS PRIMARY FUNCTION IS TO MAINTAIN A CENTRAL REPOSITORY OF CRIMINAL RECORDS, WHICH ASSISTS IN CRIMINAL JUSTICE PROCESSES, BACKGROUND CHECKS, AND PUBLIC SAFETY MEASURES.

FUNCTIONS AND RESPONSIBILITIES

THE BOARD'S KEY RESPONSIBILITIES INCLUDE THE COLLECTION AND STORAGE OF CRIMINAL HISTORY DATA, ESTABLISHING POLICIES FOR DATA DISSEMINATION, AND IMPLEMENTING PROCEDURES FOR CORRECTING INACCURATE OR OUTDATED RECORDS. ORGANIZATIONAL STRUCTURE

THE BOARD CONSISTS OF APPOINTED MEMBERS FROM VARIOUS SECTORS INCLUDING LAW ENFORCEMENT, JUDICIARY, AND PUBLIC REPRESENTATIVES. LEGAL FRAMEWORK AND AUTHORITY

ACCESS IS GENERALLY PERMITTED TO LAW ENFORCEMENT AGENCIES, CERTAIN EMPLOYERS, LICENSING AUTHORITIES, AND INDIVIDUALS REQUESTING THEIR OWN RECORDS. THE BOARD SETS FORTH SPECIFIC GUIDELINES AND APPLICATION PROCEDURES FOR EACH CATEGORY OF USER TO ENSURE PROPER USE.

REQUEST PROCEDURES

REQUESTS FOR CRIMINAL HISTORY INFORMATION TYPICALLY REQUIRE FORMAL APPLICATIONS, PROOF OF IDENTITY, AND PAYMENT OF APPLICABLE FEES. THE BOARD MAY PROVIDE RECORDS IN ELECTRONIC OR PAPER FORMAT, DEPENDING ON THE NATURE OF THE REQUEST AND THE REQUESTER'S ELIGIBILITY.

LIMITATIONS AND RESTRICTIONS

CERTAIN RECORDS MAY BE RESTRICTED OR WITHHELD TO PROTECT VICTIMS, ONGOING INVESTIGATIONS, OR SEALED RECORDS. THE BOARD ENFORCES THESE RESTRICTIONS RIGOROUSLY TO MAINTAIN CONFIDENTIALITY AND LEGAL COMPLIANCE.

RECORD SEALING AND EXPUNGEMENT PROCESSES

ONE OF THE CRITICAL FUNCTIONS OF THE CRIMINAL HISTORY SYSTEMS BOARD MASSACHUSETTS INVOLVES THE MANAGEMENT OF RECORD SEALING AND EXPUNGEMENT, WHICH ALLOWS ELIGIBLE INDIVIDUALS TO LIMIT PUBLIC ACCESS TO THEIR CRIMINAL

HISTORY UNDER SPECIFIC CONDITIONS.

ELIGIBILITY CRITERIA

ELIGIBILITY FOR SEALING OR EXPUNGEMENT DEPENDS ON FACTORS SUCH AS THE NATURE OF THE OFFENSE, THE TIME ELAPSED SINCE CONVICTION OR ARREST, AND THE INDIVIDUAL'S CRIMINAL HISTORY. THE BOARD FOLLOWS STATUTORY GUIDELINES TO DETERMINE QUALIFICATION.

APPLICATION PROCESS

APPLICANTS MUST SUBMIT DETAILED PETITIONS INCLUDING COURT DOCUMENTS, IDENTIFICATION, AND SOMETIMES PROOF OF REHABILITATION. THE BOARD REVIEWS THESE APPLICATIONS IN COORDINATION WITH THE COURTS TO GRANT OR DENY REQUESTS.

EFFECTS OF SEALING AND EXPUNGEMENT

SEALED RECORDS ARE GENERALLY INACCESSIBLE TO THE PUBLIC AND MOST EMPLOYERS BUT MAY REMAIN AVAILABLE TO LAW ENFORCEMENT. EXPUNGED RECORDS ARE DESTROYED OR REMOVED FROM OFFICIAL DATABASES, PROVIDING A HIGHER LEVEL OF PRIVACY.

PRIVACY AND DATA PROTECTION

PROTECTING THE PRIVACY OF INDIVIDUALS WHOSE INFORMATION IS CONTAINED IN THE CRIMINAL HISTORY DATABASE IS A PARAMOUNT CONCERN FOR THE CRIMINAL HISTORY SYSTEMS BOARD MASSACHUSETTS. THE BOARD IMPLEMENTS STRINGENT DATA PROTECTION MEASURES TO SAFEGUARD RECORDS FROM UNAUTHORIZED ACCESS OR DISCLOSURE.

DATA SECURITY PROTOCOLS

THE BOARD EMPLOYS ADVANCED SECURITY TECHNOLOGIES AND PROTOCOLS TO PREVENT DATA BREACHES, UNAUTHORIZED VIEWING, AND TAMPERING. THIS INCLUDES ENCRYPTION, ACCESS CONTROLS, AND REGULAR AUDITS.

CONFIDENTIALITY POLICIES

INVOLVING VULNERABLE POPULATIONS OR SECURITY-SENSITIVE ROLES. THE BOARD'S POLICIES INFLUENCE HOW AND WHEN THESE CHECKS ARE CONDUCTED AND WHAT INFORMATION CAN BE DISCLOSED.

LICENSING AND CERTIFICATION

PROFESSIONAL LICENSING BOARDS USE CRIMINAL HISTORY DATA TO EVALUATE APPLICANTS' ELIGIBILITY. THE BOARD ENSURES THAT SUCH INFORMATION IS ACCURATE AND THAT APPLICANTS HAVE THE OPPORTUNITY TO ADDRESS DISCREPANCIES OR SEEK RECORD SEALING WHERE APPLICABLE.

RIGHTS AND PROTECTIONS FOR APPLICANTS

MASSACHUSETTS LAW PROVIDES INDIVIDUALS WITH RIGHTS TO CHALLENGE INACCURATE RECORDS, OBTAIN COPIES OF THEIR HISTORIES, AND APPLY FOR SEALING OR EXPUNGEMENT, HELPING TO MITIGATE ADVERSE IMPACTS ON EMPLOYMENT AND LICENSING OPPORTUNITIES.

FREQUENTLY ASKED QUESTIONS

WHAT IS THE CRIMINAL HISTORY SYSTEMS BOARD IN MASSACHUSETTS?

THE CRIMINAL HISTORY SYSTEMS BOARD (CHSB) IN MASSACHUSETTS IS A STATE AGENCY RESPONSIBLE FOR OVERSEEING THE COLLECTION, MAINTENANCE, AND DISSEMINATION OF CRIMINAL HISTORY RECORD INFORMATION.

WHAT FUNCTIONS DOES THE MASSACHUSETTS CRIMINAL HISTORY SYSTEMS BOARD PERFORM?

THE CHSB MANAGES THE CRIMINAL OFFENDER RECORD INFORMATION (CORI) SYSTEM, ENSURING ACCURATE, SECURE, AND LAWFUL ACCESS TO CRIMINAL HISTORY DATA FOR AUTHORIZED AGENCIES AND INDIVIDUALS.

HOW CAN I REQUEST MY CRIMINAL RECORD FROM THE MASSACHUSETTS CRIMINAL HISTORY SYSTEMS BOARD?

INDIVIDUALS CAN REQUEST THEIR CRIMINAL RECORD THROUGH THE MASSACHUSETTS DEPARTMENT OF CRIMINAL JUSTICE INFORMATION SERVICES (DCJIS), WHICH OPERATES UNDER THE CHSB, BY SUBMITTING A CORI REQUEST EITHER ONLINE, BY MAIL, OR IN PERSON.

WHO CAN ACCESS CRIMINAL HISTORY INFORMATION MAINTAINED BY THE MASSACHUSETTS CHSB?

ACCESS IS LIMITED TO AUTHORIZED ENTITIES SUCH AS LAW ENFORCEMENT, EMPLOYERS IN CERTAIN INDUSTRIES, LICENSING

AGENCIES, AND INDIVIDUALS REQUESTING THEIR OWN RECORDS, SUBJECT TO STATE REGULATIONS.

ARE THERE ANY RESTRICTIONS ON HOW EMPLOYERS CAN USE CRIMINAL HISTORY INFORMATION FROM THE CHSB?

YES, MASSACHUSETTS LAW RESTRICTS THE USE OF CORI BY EMPLOYERS TO PREVENT DISCRIMINATION AND REQUIRES COMPLIANCE WITH GUIDELINES ON WHEN AND HOW CRIMINAL HISTORY CAN BE CONSIDERED IN HIRING DECISIONS.

HOW DOES THE MASSACHUSETTS CRIMINAL HISTORY SYSTEMS BOARD ENSURE THE PRIVACY OF CRIMINAL RECORDS?

THE CHSB ENFORCES STRICT SECURITY MEASURES, ACCESS CONTROLS, AND LEGAL GUIDELINES TO PROTECT THE CONFIDENTIALITY AND INTEGRITY OF CRIMINAL HISTORY INFORMATION.
