THE CURRICULUM EMPHASIZES CRITICAL THINKING, ATTENTION TO DETAIL, AND THE ABILITY TO WORK UNDER PRESSURE IN COMPLEX AND SOMETIMES DANGEROUS SITUATIONS.

## PURPOSE AND IMPORTANCE

THE PURPOSE OF A CRIMINAL INVESTIGATOR TRAINING PROGRAM IS TO PRODUCE COMPETENT PROFESSIONALS CAPABLE OF SOLVING CRIMES EFFICIENTLY AND EFFECTIVELY. HOWEVER, HAVING AN ASSOCIATE'S OR BACHELOR'S DEGREE IN CRIMINAL JUSTICE, CRIMINOLOGY, OR FORENSIC SCIENCE CAN ENHANCE ADMISSION PROSPECTS AND FUTURE CAREER OPPORTUNITIES. CERTAIN ADVANCED PROGRAMS MAY ALSO REQUIRE PRIOR LAW ENFORCEMENT EXPERIENCE.

## PHYSICAL AND PSYCHOLOGICAL REQUIREMENTS

GIVEN THE DEMANDING NATURE OF INVESTIGATIVE WORK, CANDIDATES USUALLY MUST PASS PHYSICAL FITNESS TESTS AND PSYCHOLOGICAL EVALUATIONS TO ENSURE THEY CAN PERFORM UNDER STRESS AND MAINTAIN SOUND JUDGMENT. BACKGROUND CHECKS ARE ALSO STANDARD TO VERIFY THE CANDIDATE'S INTEGRITY AND SUITABILITY FOR LAW ENFORCEMENT DUTIES.

## CORE CURRICULUM AND TRAINING MODULES
