The announcement elicited watertight counter arguments that morphed into two a priori re-litigated assumptions: First, Ghana is a secular country and second, religion and state formation are incompatible. Separating the two is, therefore, ahistorical and an obvious threat to the intangible virtues that answers, "why and how" questions for public governance.
