ORIGINS AND DEFINITION OF FORENSIC PSYCHOLOGY

FORENSIC PSYCHOLOGY IS A SPECIALIZED BRANCH OF PSYCHOLOGY THAT APPLIES PSYCHOLOGICAL KNOWLEDGE AND METHODS TO LEGAL ISSUES AND THE CRIMINAL JUSTICE SYSTEM. ITS ORIGINS CAN BE TRACED BACK TO THE LATE 19TH AND EARLY 20TH CENTURIES WHEN PSYCHOLOGISTS BEGAN COLLABORATING WITH LEGAL SYSTEMS TO PROVIDE SCIENTIFIC INSIGHTS INTO HUMAN BEHAVIOR RELEVANT TO LAW ENFORCEMENT AND JUDICIAL PROCEEDINGS.

HUGO M¹₂ NSTERBERG: THE FOUNDER OF FORENSIC PSYCHOLOGY

HUGO M¹₂ NSTERBERG (1863–1916) IS WIDELY RECOGNIZED AS THE FOUNDER OF FORENSIC PSYCHOLOGY DUE TO HIS PIONEERING EFFORTS IN APPLYING PSYCHOLOGICAL TECHNIQUES TO LEGAL QUESTIONS. BORN IN GERMANY, M¹₂ NSTERBERG WAS A STUDENT OF WILHELM WUNDT, THE FATHER OF EXPERIMENTAL PSYCHOLOGY. M¹₂ NSTERBERG LATER MOVED TO THE UNITED STATES, WHERE HE BECAME A PROMINENT FIGURE AT HARVARD UNIVERSITY. HIS INTERDISCIPLINARY APPROACH COMBINED PSYCHOLOGY WITH LAW, SETTING THE STAGE FOR FORENSIC PSYCHOLOGY AS A FORMAL DISCIPLINE.

THIS WORK WAS ONE OF THE FIRST TO SYSTEMATICALLY EXPLORE HOW PSYCHOLOGICAL SCIENCE COULD IMPROVE THE ACCURACY AND FAIRNESS OF THE JUDICIAL SYSTEM. HIS EFFORTS CHALLENGED TRADITIONAL LEGAL ASSUMPTIONS AND INTRODUCED PSYCHOLOGICAL CONCEPTS AS VITAL TOOLS FOR UNDERSTANDING HUMAN BEHAVIOR IN LEGAL CONTEXTS.

KEY CONTRIBUTIONS AND INNOVATIONS BY M² NSTERBERG

M² NSTERBERG WAS AMONG THE FIRST TO INVESTIGATE THE FALLIBILITY OF EYEWITNESS MEMORY. HE DEMONSTRATED THAT MEMORY IS SUSCEPTIBLE TO DISTORTION AND SUGGESTION, WHICH CAN LEAD TO WRONGFUL CONVICTIONS. HIS FINDINGS EMPHASIZED THE NEED FOR CAREFUL EVALUATION OF EYEWITNESS ACCOUNTS IN COURT.

FALSE CONFESSIONS AND SUGGESTION

HE ALSO EXPLORED HOW PSYCHOLOGICAL PRESSURE AND SUGGESTION COULD RESULT IN FALSE CONFESSIONS. M² NSTERBERG'S WORK HIGHLIGHTED THE DANGERS OF COERCIVE INTERROGATION TACTICS AND ADVOCATED FOR MORE SCIENTIFIC APPROACHES TO INTERVIEWING SUSPECTS.

HIS EFFORTS TO CLASSIFY CRIMINAL BEHAVIOR USING PSYCHOLOGICAL PRINCIPLES MARKED AN IMPORTANT STEP TOWARD MODERN FORENSIC ASSESSMENT PRACTICES.
