MISSION AND GOALS

The primary mission of foster family health centers is to ensure that foster children receive timely, comprehensive, and trauma-informed healthcare. The goals usually include improving health outcomes, reducing health disparities, and supporting foster families with education and resources. These centers aim to enhance the overall quality of life for foster children by addressing both immediate medical needs and long-term health considerations.

TARGET POPULATION
