IMPORTANCE OF ACCURATE VITAL STATISTICS

ACCURATE VITAL STATISTICS ARE ESSENTIAL FOR NUMEROUS APPLICATIONS, INCLUDING VERIFYING IDENTITY, ESTABLISHING LEGAL RIGHTS, AND CONDUCTING MEDICAL RESEARCH. MARRIAGE LICENSES AND CERTIFICATES

MARRIAGE LICENSES AUTHORIZE A COUPLE TO MARRY AND ARE TYPICALLY ISSUED BEFORE THE MARRIAGE CEREMONY. AFTER THE CEREMONY, A MARRIAGE CERTIFICATE IS CREATED AS PROOF OF THE LEGAL UNION. THESE DOCUMENTS ARE OFTEN REQUIRED FOR LEGAL NAME CHANGES, TAX FILING, AND SPOUSAL BENEFITS.

DIVORCE DECREES

DIVORCE DECREES OFFICIALLY TERMINATE A MARRIAGE AND OUTLINE THE TERMS AGREED UPON OR ORDERED BY THE COURT, INCLUDING CHILD CUSTODY, SUPPORT, AND PROPERTY DIVISION. COPIES OF DIVORCE RECORDS ARE OFTEN NECESSARY FOR LEGAL AND ADMINISTRATIVE PURPOSES.

HOW TO REQUEST VITAL RECORDS IN FRANKLIN COUNTY

FEES AND PROCESSING TIMES

YOU CAN REQUEST A BIRTH CERTIFICATE BY VISITING THE FRANKLIN COUNTY VITAL STATISTICS OFFICE IN PERSON, SUBMITTING AN ONLINE APPLICATION THROUGH THEIR OFFICIAL WEBSITE, OR MAILING A COMPLETED REQUEST FORM ALONG WITH THE REQUIRED IDENTIFICATION AND FEES.

ARE MARRIAGE LICENSE APPLICATIONS AVAILABLE ONLINE THROUGH FRANKLIN COUNTY VITAL STATISTICS?

MANY FRANKLIN COUNTY VITAL STATISTICS OFFICES OFFER ONLINE APPLICATIONS OR DOWNLOADABLE FORMS FOR MARRIAGE LICENSES, BUT SOME STEPS MAY REQUIRE AN IN-PERSON VISIT, SUCH AS THE LICENSE ISSUANCE OR CEREMONY.
