OVERVIEW OF FREDERICKSBURG VA TAX ASSESSMENT

Assessment Notices and Updates

ONCE VALUES ARE CALCULATED, PROPERTY OWNERS RECEIVE OFFICIAL ASSESSMENT NOTICES DETAILING THE NEW VALUATION. THESE NOTICES TYPICALLY ARRIVE ANNUALLY AND PROVIDE THE ASSESSED VALUE AS WELL AS INSTRUCTIONS ON HOW TO REQUEST MORE INFORMATION OR FILE AN APPEAL. THE ASSESSMENT VALUES ARE UPDATED REGULARLY TO REFLECT MARKET TRENDS AND ANY CHANGES TO THE PROPERTY.

Understanding Property Tax Rates and Their Calculation

AFTER THE ASSESSMENT ESTABLISHES THE PROPERTY'S VALUE, FREDERICKSBURG APPLIES A TAX RATE TO DETERMINE THE ACTUAL TAX OWED BY THE PROPERTY OWNER. THIS SECTION EXPLAINS THE RELATIONSHIP BETWEEN ASSESSED VALUES AND TAX RATES AND HOW PROPERTY TAX BILLS ARE CALCULATED.

Tax Rate Determination

THIS RATE IS INFLUENCED BY THE CITY'S REVENUE NEEDS, ECONOMIC CONDITIONS, AND POLICY DECISIONS. PROPERTY TAX RATES CAN VARY SLIGHTLY YEAR-TO-YEAR BASED ON THESE FACTORS.

CALCULATING PROPERTY TAXES

THE FORMULA TO CALCULATE PROPERTY TAXES IN FREDERICKSBURG IS STRAIGHTFORWARD:

1. DETERMINE THE ASSESSED VALUE OF THE PROPERTY (AS PROVIDED IN THE TAX ASSESSMENT NOTICE).
2. DIVIDE THE ASSESSED VALUE BY 100.
3. MULTIPLY THE RESULT BY THE CURRENT TAX RATE.

FOR EXAMPLE, IF A PROPERTY IS ASSESSED AT \$300,000 AND THE TAX RATE IS \$1.20 PER \$100 OF ASSESSED VALUE, THE PROPERTY TAX WOULD BE:

$$(300,000 / 100) \times 1.20 = \$3,600 \text{ ANNUALLY.}$$

ADDITIONAL LOCAL TAXES AND FEES

BESIDES THE BASIC PROPERTY TAX, SOME PROPERTY OWNERS MAY BE SUBJECT TO ADDITIONAL LOCAL ASSESSMENTS OR FEES, SUCH AS SPECIAL DISTRICT LEVIES OR SERVICE CHARGES. THESE ARE TYPICALLY DETAILED ON THE PROPERTY TAX BILL AND ARE USED TO FUND SPECIFIC LOCAL PROJECTS OR SERVICES.

APPEALING A FREDERICKSBURG PROPERTY TAX ASSESSMENT

HEARING AND RESOLUTION

AFTER FILING, THE PROPERTY OWNER MAY BE INVITED TO A HEARING WHERE THEY CAN PRESENT THEIR CASE IN PERSON. THE BOARD OR COMMISSIONER REVIEWS THE EVIDENCE AND DETERMINES WHETHER AN ADJUSTMENT TO THE ASSESSED VALUE IS

WARRANTED. DECISIONS ARE COMMUNICATED IN WRITING, AND FURTHER APPEALS MAY BE AVAILABLE TO CIRCUIT COURTS IF NECESSARY.

TAX RELIEF PROGRAMS IN FREDERICKSBURG, VA

FREDERICKSBURG OFFERS SEVERAL TAX RELIEF PROGRAMS DESIGNED TO ASSIST ELIGIBLE PROPERTY OWNERS, PARTICULARLY SENIORS, VETERANS, AND DISABLED INDIVIDUALS. THESE PROGRAMS CAN REDUCE THE PROPERTY TAX BURDEN THROUGH EXEMPTIONS, DEFERRALS, OR CREDITS.

SENIOR CITIZEN AND DISABLED TAX RELIEF

THESE PROGRAMS MAY OFFER PARTIAL OR FULL EXEMPTIONS ON A PORTION OF THE ASSESSED VALUE, LOWERING ANNUAL TAX BILLS. APPLICANTS MUST SUBMIT PROOF OF ELIGIBILITY AND APPLY ANNUALLY TO MAINTAIN BENEFITS.

VETERAN TAX EXEMPTIONS

QUALIFIED VETERANS, INCLUDING DISABLED VETERANS, MAY BE ELIGIBLE FOR PROPERTY TAX EXEMPTIONS OR REDUCTIONS. THESE BENEFITS RECOGNIZE THE SERVICE AND SACRIFICES MADE BY MILITARY MEMBERS AND CAN SIGNIFICANTLY DECREASE PROPERTY TAX LIABILITY. DOCUMENTATION SUCH AS MILITARY SERVICE RECORDS AND DISABILITY RATINGS ARE REQUIRED FOR APPLICATION.

OTHER AVAILABLE RELIEF OPTIONS

FREDERICKSBURG MAY ALSO OFFER ADDITIONAL RELIEF PROGRAMS FOR LOW-INCOME HOMEOWNERS OR SPECIAL CIRCUMSTANCES. IT IS ADVISABLE FOR PROPERTY OWNERS TO CONSULT THE CITY'S TAX ASSESSOR'S OFFICE OR LOCAL GOVERNMENT RESOURCES TO DETERMINE ELIGIBILITY AND APPLICATION PROCEDURES.
