UNDERSTANDING IDAHO PHYSICAL THERAPY LICENSING

TO OBTAIN A LICENSE, APPLICANTS MUST COMPLETE AN ACCREDITED PHYSICAL THERAPY EDUCATION PROGRAM, PASS THE NATIONAL PHYSICAL THERAPY EXAMINATION (NPTE), AND FULFILL ANY ADDITIONAL STATE-SPECIFIC REQUIREMENTS.

LICENSING REQUIREMENTS IN IDAHO

IDAHO MANDATES SEVERAL CRITERIA FOR PHYSICAL THERAPISTS TO BE ELIGIBLE FOR LICENSURE. THESE REQUIREMENTS INCLUDE:

- GRADUATION FROM A COMMISSION ON ACCREDITATION IN PHYSICAL THERAPY EDUCATION (CAPTE) ACCREDITED PROGRAM
- SUCCESSFUL PASSAGE OF THE NPTE
- SUBMISSION OF AN APPLICATION WITH APPROPRIATE FEES TO THE IDAHO PHYSICAL THERAPY LICENSING BOARD
- COMPLETION OF A BACKGROUND CHECK AND VERIFICATION OF PROFESSIONAL CREDENTIALS
- COMPLIANCE WITH IDAHO STATE LAWS AND REGULATIONS GOVERNING PHYSICAL THERAPY PRACTICE

MEETING THESE REQUIREMENTS ENSURES THAT LICENSED PHYSICAL THERAPISTS IN IDAHO POSSESS THE NECESSARY EXPERTISE AND QUALIFICATIONS TO PRACTICE SAFELY AND EFFECTIVELY.

TYPES OF LICENSES ISSUED

THE IDAHO PHYSICAL THERAPY LICENSING BOARD ISSUES SEVERAL TYPES OF LICENSES, INCLUDING:

- PHYSICAL THERAPIST (PT) LICENSE – FOR INDIVIDUALS FULLY LICENSED TO PRACTICE PHYSICAL THERAPY INDEPENDENTLY.

STEPS TO VERIFY A PHYSICAL THERAPY LICENSE IN IDAHO

THIS METHOD PROVIDES IMMEDIATE AND RELIABLE VERIFICATION OF PHYSICAL THERAPY LICENSES.
