WHO MUST TAKE THE TEST?

- CURVE AHEAD
- PEDESTRIAN CROSSING
- SLIPPERY WHEN WET
- ANIMAL CROSSING
- ROADWORK AHEAD

GUIDE AND INFORMATION SIGNS

GUIDE SIGNS PROVIDE NAVIGATIONAL INFORMATION, SUCH AS DIRECTIONS, DISTANCES, AND POINTS OF INTEREST. THEY ARE OFTEN RECTANGULAR AND USE GREEN, BLUE, OR BROWN COLORS. EXAMPLES INCLUDE:

- HIGHWAY ROUTE MARKERS
- EXIT SIGNS
- MILE MARKERS
- REST AREA SIGNS
- HOSPITAL OR SERVICE SIGNS

FORMAT AND STRUCTURE OF THE IDAHO ROAD SIGNS TEST
