IT IS DESIGNED TO SIMPLIFY THE PROCESS OF RECEIVING MEDICAL CARE BY CONSOLIDATING MEMBER INFORMATION, COVERAGE DETAILS, AND BENEFITS INTO A SINGLE CARD. THE IEHP VIBRANT HEALTH CARD IS RECOGNIZED BY DOCTORS, HOSPITALS, PHARMACIES, AND OTHER HEALTHCARE PROFESSIONALS WITHIN THE INLAND EMPIRE REGION.

FEATURES OF THE IEHP VIBRANT HEALTH CARD

THE CARD INCLUDES ESSENTIAL INFORMATION SUCH AS THE MEMBER'S NAME, IDENTIFICATION NUMBER, GROUP NUMBER, AND CONTACT INFORMATION FOR CUSTOMER SERVICE. HOW TO OBTAIN THE IEHP VIBRANT HEALTH CARD

NEW MEMBERS OF INLAND EMPIRE HEALTH PLAN RECEIVE THE IEHP VIBRANT HEALTH CARD SHORTLY AFTER ENROLLING IN THE

HEALTH PLAN. THE CARD IS USUALLY MAILED TO THE MEMBER'S REGISTERED ADDRESS WITHIN A FEW WEEKS OF ENROLLMENT. FOR EXISTING MEMBERS WHO HAVE LOST THEIR CARD OR NEED A REPLACEMENT, IEHP PROVIDES STRAIGHTFORWARD OPTIONS TO REQUEST A NEW CARD.

ENROLLMENT PROCESS AND CARD ISSUANCE

ENROLLMENT IN IEHP CAN BE COMPLETED ONLINE, BY PHONE, OR THROUGH AUTHORIZED ENROLLMENT CENTERS. ONCE THE APPLICATION IS APPROVED, MEMBERS RECEIVE CONFIRMATION ALONG WITH THE IEHP VIBRANT HEALTH CARD. IT IS IMPORTANT THAT MEMBERS PROVIDE ACCURATE CONTACT INFORMATION TO AVOID DELAYS IN RECEIVING THE CARD.

REQUESTING A REPLACEMENT CARD

IF THE IEHP VIBRANT HEALTH CARD IS LOST, STOLEN, OR DAMAGED, MEMBERS CAN REQUEST A REPLACEMENT BY CONTACTING IEHP CUSTOMER SERVICE. REQUESTS CAN TYPICALLY BE MADE VIA PHONE, THROUGH THE MEMBER PORTAL, OR BY MAIL. REPLACEMENT CARDS ARE SENT OUT PROMPTLY TO MINIMIZE ANY DISRUPTION TO HEALTHCARE ACCESS.

UPDATING PERSONAL INFORMATION

HOW DO I USE MY IEHP VIBRANT HEALTH CARD?

YOU PRESENT YOUR IEHP VIBRANT HEALTH CARD TO HEALTH CARE PROVIDERS, PHARMACIES, AND OTHER AUTHORIZED SERVICE PROVIDERS TO RECEIVE COVERED MEDICAL SERVICES AND PRESCRIPTIONS UNDER YOUR IEHP PLAN.

CAN I USE THE IEHP VIBRANT HEALTH CARD AT ANY DOCTOR OR HOSPITAL?

THE IEHP VIBRANT HEALTH CARD IS ACCEPTED BY PROVIDERS WITHIN THE IEHP NETWORK. YOU SHOULD USE PROVIDERS WHO ACCEPT IEHP TO ENSURE YOUR SERVICES ARE COVERED AND TO AVOID OUT-OF-POCKET COSTS.

WHAT SHOULD I DO IF I LOSE MY IEHP VIBRANT HEALTH CARD?

IF YOU LOSE YOUR IEHP VIBRANT HEALTH CARD, YOU SHOULD CONTACT IEHP MEMBER SERVICES IMMEDIATELY TO REQUEST A REPLACEMENT CARD TO CONTINUE RECEIVING BENEFITS WITHOUT INTERRUPTION.
