BACKGROUND AND HISTORICAL CONTEXT

CREATION OF THE SECOND BANK OF THE UNITED STATES

CONGRESS CHARTERED THE SECOND BANK OF THE UNITED STATES IN 1816 TO STABILIZE THE NATIONAL ECONOMY AND PROVIDE A UNIFORM CURRENCY. HOWEVER, NOT ALL STATES WELCOMED THE FEDERAL BANK, VIEWING IT AS A THREAT TO STATE BANKS AND ECONOMIC INDEPENDENCE. MARYLAND'S ATTEMPT TO TAX THE BANK WAS A DIRECT CHALLENGE TO FEDERAL AUTHORITY AND SET THE STAGE FOR THE SUPREME COURT TO ADDRESS THE CONSTITUTIONALITY OF THE BANK AND THE LIMITS OF STATE POWER.

POLITICAL CLIMATE AND FEDERALISM

DURING THIS PERIOD, DEBATES OVER FEDERALISM—HOW POWER SHOULD BE DIVIDED BETWEEN THE NATIONAL AND STATE GOVERNMENTS—WERE HIGHLY CONTENTIOUS. STATES' RIGHTS ADVOCATES SOUGHT TO LIMIT FEDERAL INFLUENCE, WHEREAS PROPONENTS OF A STRONG NATIONAL GOVERNMENT ARGUED FOR BROAD FEDERAL POWERS TO MAINTAIN UNITY AND ECONOMIC STABILITY. THE MCCULLOCH CASE BECAME A PIVOTAL MOMENT IN THIS ONGOING DEBATE.

KEY LEGAL QUESTIONS IN McCULLOCH V MARYLAND

AUTHORITY TO ESTABLISH THE BANK

THE CENTRAL QUESTION WAS WHETHER THE CREATION OF THE BANK OF THE UNITED STATES WAS WITHIN THE SCOPE OF POWERS GRANTED TO CONGRESS. OPPONENTS ARGUED THAT SINCE THE CONSTITUTION DID NOT EXPLICITLY AUTHORIZE THE BANK, CONGRESS HAD OVERSTEPPED ITS BOUNDS. SUPPORTERS POINTED TO THE NECESSARY AND PROPER CLAUSE, WHICH ALLOWS CONGRESS TO ENACT LAWS ESSENTIAL FOR EXECUTING ITS ENUMERATED POWERS.

STATE TAXATION OF FEDERAL INSTITUTIONS

THE SECOND ISSUE CONCERNED MARYLAND'S ATTEMPT TO TAX THE BANK. THE STATE ARGUED THAT TAXING THE BANK WAS A LEGITIMATE EXERCISE OF ITS SOVEREIGN POWERS. HOWEVER, THE FEDERAL GOVERNMENT CONTENDED THIS TAXATION INTERFERED WITH FEDERAL OPERATIONS AND VIOLATED CONSTITUTIONAL PRINCIPLES THAT PROTECT FEDERAL SUPREMACY.

THE SUPREME COURT DECISION AND REASONING

THE SUPREME COURT, LED BY CHIEF JUSTICE JOHN MARSHALL, DELIVERED A UNANIMOUS DECISION IN FAVOR OF McCULLOCH AND THE FEDERAL GOVERNMENT. THE RULING ESTABLISHED IMPORTANT PRECEDENTS REGARDING FEDERAL AUTHORITY AND STATES' LIMITATIONS. THE COURT FURTHER RULED THAT MARYLAND'S TAX ON THE BANK WAS UNCONSTITUTIONAL AS IT INTERFERED WITH FEDERAL OPERATIONS. THE SUPREMACY CLAUSE ESTABLISHES THAT FEDERAL LAWS TAKE PRECEDENCE OVER CONFLICTING STATE LAWS, PROHIBITING STATES FROM TAXING OR HINDERING VALID FEDERAL ENTITIES. THIS PRINCIPLE REINFORCED THE CONCEPT OF FEDERAL SUPREMACY WITHIN THE AMERICAN CONSTITUTIONAL SYSTEM.

CONSTITUTIONAL PRINCIPLES ESTABLISHED

FEDERAL SUPREMACY

LIMITATIONS ON STATE POWERS
