UNDERSTANDING THE WEST VIRGINIA PERMIT TEST

THE WEST VIRGINIA PERMIT TEST IS A KNOWLEDGE EXAM DESIGNED TO ASSESS A PROSPECTIVE DRIVER'S UNDERSTANDING OF STATE TRAFFIC LAWS, ROAD SIGNS, AND SAFE DRIVING PRACTICES. PURPOSE OF THE PERMIT TEST

- PROOF OF WEST VIRGINIA RESIDENCY
- COMPLETED APPLICATION FORM
- PARENTAL OR GUARDIAN CONSENT IF UNDER 18 YEARS OF AGE

THESE DOCUMENTS VERIFY ELIGIBILITY AND ENSURE COMPLIANCE WITH STATE LAWS.
