ACCEPTABLE DOCUMENTS INCLUDE BIRTH CERTIFICATES, SOCIAL SECURITY CARDS, AND UTILITY BILLS OR SCHOOL RECORDS FOR RESIDENCY. THESE DOCUMENTS ARE VERIFIED DURING THE APPLICATION PROCESS PRIOR TO SCHEDULING THE DRIVING TEST.

COMPONENTS OF THE PRACTICE DRIVING TEST IOWA
