ALTERNATIVES INCLUDE ABSTAINING FROM DRUG USE, DETOXIFICATION PROGRAMS, USING HOME DRUG TESTS TO CHECK BEFORE THE OFFICIAL TEST, OR REQUESTING A RETEST IF THERE ARE DOUBTS ABOUT ACCURACY.
