4. **DETERMINE TOTAL AMOUNT:** ADD THE BASE PRICE, TAX AMOUNT, AND TIP AMOUNT TO OBTAIN THE TOTAL PAYMENT DUE.
5. **REVIEW AND VERIFY:** DOUBLE-CHECK INPUT VALUES AND CALCULATIONS FOR ACCURACY BEFORE FINALIZING THE WORKSHEET.

TIPS FOR DIGITAL WORKSHEETS

WHEN UTILIZING SPREADSHEET SOFTWARE, USERS CAN INCORPORATE FORMULAS TO AUTOMATE CALCULATIONS AND REDUCE HUMAN ERROR.
