# UNDERSTANDING DRUG TESTS AND VAPING

Drug tests are designed to detect specific substances or their metabolites in the body. Common testing methods include urine, blood, saliva, and hair follicle tests. The goal is to identify the presence of illegal drugs, prescription medications, or other controlled substances. NICOTINE IS USUALLY NOT INCLUDED IN STANDARD DRUG TESTS BUT MAY BE CHECKED IN SPECIFIC SCREENINGS. THC, COMMONLY FOUND IN CANNABIS VAPE PRODUCTS, IS THE PRIMARY COMPOUND THAT DRUG TESTS AIM TO DETECT WHEN CONSIDERING VAPING.

## NICOTINE VAPING AND DRUG TESTS

NICOTINE, THE ADDICTIVE SUBSTANCE FOUND IN TOBACCO AND MANY VAPE LIQUIDS, IS NOT CLASSIFIED AS AN ILLEGAL DRUG AND TYPICALLY DOES NOT APPEAR ON STANDARD DRUG TESTS USED FOR EMPLOYMENT OR LEGAL PURPOSES. HOWEVER, SOME SPECIALIZED TESTS SPECIFICALLY SCREEN FOR NICOTINE OR ITS METABOLITE COTININE TO MONITOR TOBACCO USE OR SMOKING CESSATION PROGRAMS.

## WILL NICOTINE SHOW UP ON A DRUG TEST?

STANDARD EMPLOYMENT DRUG TESTS GENERALLY DO NOT INCLUDE NICOTINE IN THEIR SCREENING PANEL. NONETHELESS, CERTAIN MEDICAL OR INSURANCE-RELATED TESTS MAY TEST FOR NICOTINE OR COTININE TO ASSESS SMOKING HABITS. THEREFORE, VAPING NICOTINE ALONE USUALLY WILL NOT CAUSE A POSITIVE RESULT ON TYPICAL DRUG TESTS.

## NICOTINE TESTING METHODS

WHEN NICOTINE TESTING IS CONDUCTED, IT USUALLY INVOLVES:

- Urine tests: Detect cotinine, a nicotine metabolite, for up to 3-4 days after use.
- BLOOD TESTS: MEASURES NICOTINE OR COTININE LEVELS FOR RECENT USE.
- SALIVA TESTS: DETECT COTININE WITHIN A SIMILAR DETECTION WINDOW AS URINE TESTS.

THESE TESTS ARE SPECIFIC AND ARE NOT PART OF ROUTINE DRUG SCREENINGS.

# CANNABIS VAPING AND DRUG TESTS

CANNABIS VAPING INVOLVES INHALING VAPORIZED CANNABIS EXTRACTS THAT CONTAIN THC, THE PSYCHOACTIVE COMPOUND RESPONSIBLE FOR THE "HIGH" SENSATION. THC AND ITS METABOLITES ARE THE PRIMARY SUBSTANCES THAT DRUG TESTS AIM TO DETECT WHEN SCREENING FOR CANNABIS USE.

### WILL THC FROM VAPING SHOW UP ON A DRUG TEST?

YES, VAPING THC CAN LEAD TO A POSITIVE DRUG TEST RESULT. DRUG TESTS TYPICALLY DETECT THC METABOLITES, SUCH AS THC-COOH, IN URINE, BLOOD, SALIVA, OR HAIR SAMPLES. THESE METABOLITES REMAIN IN THE BODY LONGER THAN THE ACTIVE THC ITSELF AND ARE THE MARKERS USED FOR DRUG SCREENING.

## DIFFERENCES BETWEEN SMOKING AND VAPING CANNABIS

While both methods introduce THC into the body, vaping cannabis may deliver higher concentrations of THC more efficiently, potentially leading to higher metabolite levels in the body. However, the detection principles remain the same, and drug tests do not differentiate between vaping and smoking cannabis.

# DETECTION TIMES FOR VAPING SUBSTANCES

THE DETECTION WINDOW FOR SUBSTANCES FROM VAPING VARIES DEPENDING ON THE COMPOUND, FREQUENCY OF USE, INDIVIDUAL METABOLISM, AND THE TYPE OF TEST ADMINISTERED.

### NICOTINE DETECTION TIMES

NICOTINE AND ITS METABOLITES TYPICALLY REMAIN DETECTABLE FOR:

• Up to 3-4 days in urine

- 1-3 DAYS IN SALIVA
- UP TO 10 DAYS IN BLOOD
- LONGER IN HAIR SAMPLES (UP TO 90 DAYS)

THESE DURATIONS APPLY WHEN NICOTINE TESTING IS SPECIFICALLY PERFORMED.

## THC DETECTION TIMES

THC METABOLITES CAN BE DETECTED IN VARIOUS TESTS FOR DIFFERENT TIMEFRAMES:

- **Urine:** 3-30 days depending on usage frequency; occasional users may test positive for up to 3 days, while chronic users can test positive for over a month.
- BLOOD: 1-7 DAYS FOR OCCASIONAL USERS; LONGER FOR HEAVY USERS.
- SALIVA: 1-3 DAYS APPROXIMATELY.
- HAIR: UP TO 90 DAYS OR MORE.

# FACTORS INFLUENCING DRUG TEST RESULTS FROM VAPING

# FREQUENCY AND AMOUNT OF USE

REGULAR AND HEAVY VAPING, ESPECIALLY OF THC-CONTAINING PRODUCTS, INCREASES THE LIKELIHOOD OF DETECTION AND EXTENDS THE PERIOD SUBSTANCES REMAIN IN THE BODY. OCCASIONAL OR ONE-TIME USE GENERALLY RESULTS IN SHORTER DETECTION WINDOWS.

#### INDIVIDUAL METABOLISM

METABOLIC RATE, BODY FAT PERCENTAGE, HYDRATION, AND OVERALL HEALTH INFLUENCE HOW QUICKLY THE BODY PROCESSES AND ELIMINATES SUBSTANCES FROM VAPING.

### TYPE OF VAPED SUBSTANCE

VAPING PURE NICOTINE E-LIQUIDS DIFFERS SIGNIFICANTLY FROM VAPING CANNABIS CONCENTRATES. THE CHEMICAL COMPOSITION AND METABOLISM OF SUBSTANCES AFFECT DETECTION PROBABILITIES.

# TEST SENSITIVITY AND CUTOFF LEVELS

DRUG TESTS VARY IN SENSITIVITY. LOWER CUTOFF LEVELS INCREASE THE CHANCE OF DETECTING TRACE AMOUNTS, WHILE HIGHER THRESHOLDS MAY NOT DETECT INFREQUENT OR LOW-DOSE VAPING.

# COMMON CAUSES OF FALSE POSITIVES

Some legal substances or medications might cause false positives in drug tests. For example, certain over-the-counter products or CBD vape oils might trigger ambiguous results due to cross-reactivity.

### TIPS TO AVOID TESTING POSITIVE FROM VAPING

- 1. Avoid vaping THC-containing products before a drug test to prevent positive results.
- 2. Use NICOTINE-ONLY VAPE PRODUCTS IF NICOTINE TESTING IS NOT REQUIRED.
- 3. CHECK PRODUCT INGREDIENTS TO ENSURE NO HIDDEN CANNABINOIDS OR ILLICIT SUBSTANCES.
- 4. ALLOW SUFFICIENT TIME BETWEEN VAPING AND TESTING BASED ON DETECTION WINDOWS.
- 5. **INFORM THE TESTING AUTHORITY** ABOUT ANY PRESCRIBED MEDICATIONS OR SUPPLEMENTS.

BEING INFORMED AND CAUTIOUS IS KEY TO MANAGING DRUG TEST OUTCOMES RELATED TO VAPING.

YES, VAPING SYNTHETIC CANNABINOIDS CAN CAUSE A POSITIVE DRUG TEST SINCE THESE SUBSTANCES ARE OFTEN INCLUDED IN DRUG SCREENING PANELS.

# DOES PASSIVE EXPOSURE TO VAPING CAUSE A POSITIVE DRUG TEST?

PASSIVE EXPOSURE TO VAPING, ESPECIALLY NICOTINE OR THC, IS UNLIKELY TO CAUSE A POSITIVE DRUG TEST BECAUSE THE AMOUNT ABSORBED IS TYPICALLY TOO LOW TO TRIGGER DETECTION.
