## HOW DRUG TESTS DETECT CANNABIS

Drug tests are designed to identify the presence of specific substances or their metabolites in biological samples. When it comes to cannabis, most tests target the detection of tetrahydrocannabinol (THC) metabolites rather than THC itself. These metabolites, such as 11-nor-9-carboxy-THC (THC-COOH), remain in the body for varying periods depending on usage patterns and individual metabolism.

## METABOLISM OF EDIBLES AND THC IN THE BODY

This metabolite is further broken down into THC-COOH, which is non-psychoactive but detectable in drug tests.

### DIFFERENCES BETWEEN EDIBLES AND SMOKING

COMPARED TO SMOKING OR VAPING, EDIBLES GENERALLY PRODUCE A SLOWER ONSET OF EFFECTS BUT PROLONGED DURATION.
